Parents with past due tuition/fees balance may be charged \$25.00 late fee to their FACTS account; student(s) may not be allowed to take mid-term or final exams; be blocked access to online grade view; not be issued report cards/diplomas/transcripts and/or may be disenrolled from the school. I will sign scholarship check, if applicable, within 7 days of being notified by the school staff. Failure to do so may result in loss of scholarship.
- ✚ I fully comprehend that families that have been Active Parishioners at Little Flower Catholic School for at least 12 months prior to enrollment to Little Flower Catholic School will pay the active Family Turion rates and fees. An Active parishioner is a family that is registered at Little Flower Catholic Church, participates in the faith life of the parish by given fully or their time, talent, and treasure and by regularly attending Sunday Mass and Holy Days of Obligation for the previous 12 months.
- ✚ I understand that tuition alone does not pay for the total cost of educating a student. I agree to support our school through fundraising to the best of my ability.
- ✚ I agree to participate and serve the requested hours through school approved activities and programs, including the Home and School association fundraising events as outlined in the Parent Student Handbook.
